1. Kieki Bharat Nirman Volunteer?

Ki Bharat Nirman Volunteer ki long ki briel u ba trei mon sngewbha ban iarap ia ki longing longsem kiba duk ha ki jaka nongkydeng ba kin ioh ia ki jingiarap hapoh ki skhim bapher bapher jong ka Sorkar Jylla bad Sorkar Kmie.

2. Balei donkam ia ki Bharat Nirman Volunteer?

Ka Sorkar Jylla bad ka Sorkar Kmie kala pyntreikam ia ki skhim bapher bapher da ka jingthmu ban ai jingiarap bad jingmyntoi ki longing kiba duk. Hynrei la shem pynban ba bunsien ki jingmyntoi kim poi sha ki longing longsem kiba dei ban ioh ia ki. Kumta la donkam ia ki Bharat Nirman Volunteer ha man la ki shnong ban kham pynsngewthuh bad pynshai shaphang ki skhim jong ka Sorkar sha ki longing ba duk khnang ba kin tip kham bha ia ki jingmyntoi ba ki lah ban ioh na kawei pa kawei ka skhim bad kumno ban ioh pdiang ia ki.

3. Kieki jingthmu jong ki Bharat Nirman Volunteers?

Ki jingthmu jong ki Bharat Nirman Volunteers ki long kumne harum:

- (i) **Close Contact:** lane ban wanrah iaka ka jingiae kaba kham jan hapdeng ka sorkar bad ki nong shong shnong lane ki nongioh myntoi na ki skhim bapher bapher.
- (ii) **Generate awareness:** lane ban ai jingpynshai shaki paibah ha kaba iadei bad ki skhim sorkar bad kumnò ba kin lah ban ioh myntoi na ki bad pyntreikam bha ia ki.
- (iii) **Social audit:** Ban pynshai, pynshlur bad ban iarap ia ki briel ban pyntreikam ia ka social audit.
- (iv) **Encourage Legal Literacy:** Ban hikai ia ki briel halor ki hok jong ki hapoh ki programme bapher bapher jong ka Sorkar bad ban hikai ia ki briel ba kin long kiba tip aiñ tip kanon.
- (v) **Support Local Councils:** Ban iarap ia ki Local Councils (ka Dorbar Shnong, ki VECs, AECs bad ki PEICs) ha ka jingtrei kam jong ki.
- (vi) **Grievance Redress:** Ban pynstet bad weng ia ki jingeh jong ki briel bad iarap ha ka jingtrei kam jong ki lad ai jingiarap.

- (vii) **Improvement of implementation & feedback:** Ban kham pynbha ia ka rukom treikam iaki skim bapher bapher jong ka sorkar hapoh ka shnong, bad ban pyntip ia ki jingdonkam sha ki bor ba dei peit.
- (viii) **Develop Leadership:** Ban pynrung ia ka mynsiem nongialam hapdeng ki briel ba kin long kiba shlur ban mih bad trei na ka bynta ka hok.
- (ix) **Cadre of Trained Volunteers:** Ban wanrah ia ka kynhun ki nongtrei mon sngewbha, kiba la ioh ia ki jinghikai bad kiba la kut jingmut ban wanrah ia ki jingkylla ha ki kam pynroi pynsan.
- (x) **Maintain Peace and Harmony:** Ban wanrah iaka jingia sngewthuh jingmut hapdeng ki para nongshong shnong ban ioh iaka suk ka sain khnang ban kiew haka roi ka par.
4. Kumno ban register kum ki Bharat Nirman Volunteers?
Kino kino kito kiba la kut jingmut ban ia noh synriang sha ki jingpyntreikam halor ka manbha longbha bad ki lad ki lynti pynroi pynsan ka sorkar, ki lah ban pan na ki Block ne Dorbar/VEC ban long ki nongtrei mon sngewbha Bharat Nirman. Dei ban long palat 18 snem ka rta.

Ki Volunteer ki la ban bat kam shirta tangba ki dei ruh ban long kiba don burom don akor bad ki ba pynbiang lut ia ki kam baroh. La kumno kumno shi bynta na ka lai bynta jong ki nongtrei mon sngewbha ki dei ban long ki riew kynthei.
6. Kumno ki Volunteer kin trei kam?

13. Kiei ki mat treikam jong ki Bharat Nirman Volunteer?

Ki mat trei kam jong ki Volunteer ki long kumne harum:

- (i) **Awareness:** Ban pyntip sha ki briew halor ki Programmes kiba wanrah iaka roi ka par hapoh Shnong.
- (ii) **People Participation:** Ban pynshlur ia ki briew ban ia shim bynta ha ki kam kiba wanrah ia ka roi ka par hapoh shnong kum ka planning, execution, monitoring bad kiwei kiwei.
- (iii) **Social Audit:** Ban pynshlur ia ki briew ban ia shim bynta ha ka social audit khnang ban ioh ia ka jingshai halor ka jing pyntrei kam ia ki skim hapoh shnong.

- (iv) **Rural Reporters & Data Entry:** Ban long ki nongrah khubor sha ki biew ia ki kam ba wanrah ia ka roi ka pa kaba la pyntrei da ka sorkar bad ki dei ban pyntip ruh ia ki rukom treikam bad ki rukom pyniaid iaki kam hapoh shnong bad ban phah iaki sha ki nongpyniaid shnong bad kumjuh ruh sha ka Block.
- (v) **Vigilance and Monitoring:** Ki dei ban bud dien bad jurip ia ki kam bapher khnang ba kine ki kam kin long kiba iaid beit iaid ryntih.
- (vi) **Census:** Ban buh jingkhein lane jingthoh ha kaba iadei bad ki longing, ki SHG, ki jait jingtrei kiba la trei bad kumjuh ruh ban pyniarap haka khana samari khnang ban ioh jingtip kaba paka halor ki longing ha nongkyndong.
- (vii) **Feedback:** Ban lum ban phah jingtip sha u BDO ha kaba iadei bad ki jingtrei kam ki skhim Sorkar bad halor ki jingdonkam jong ka shnong.
- (viii) **SHGs:** Ki BNV ki dei ban pynshlur ia ki nongshong shnong ban seng ia ki SHGs bad ban ai jinghikai bad jingtip ia ki rukom bad kyndon treikam jong ka SHGs.
- (ix) **House sites and Housing:** Ki Volunteer ki dei ban report ia kito ki baduk ki bym don ing don sem sha ka Block bad ban iarap ia ki ban ioh ia ka ing hapoh ka housing programme jong ka IAY bad ban peit ruh kumjuh ba ia ka fund ne ka pisa ka iaid sha ki baduk na ka Block khlem don kano kano ka jingthut.
- (x) **Health and Sanitation:** Haba don kino kino ki jait jingpang ha shnong kum ka HIV, Malaria, T.B. bad kiwei kiwei, ki Volunteer ki dei ban report sha ki doctor bad sha ki nongtrei jong ka ASHA ne ANM ban ioh ia ki dawai bad jingsumar. Ki dei ruh ban pynshlur ia ki longing longsem ba kin shna ia la ki jong ki paiñkhanna bad ban leh khuid khnang ba ka shnong ka lah ban ioh ia ka Nirmal Gram Puraskar.
- (xi) **Food Security:** Ki Volunteer ki dei ban peit ia kito ki longing ki byn don ration card bad ban report ia ki sha ki nongkitkam shnong bad ka Block. Ki dei ruh ban report ia ka jingduna ne ia ka jingslem ban wanrah ia ki ration.
- (xii) **Any Other work:** Ki Volunteer ki lah ban shim ia kiwei kiwei pat ki kam kiba wanrah ia ka jingbha jong ka shnong ka thaw.
